Christian Children's Home of Ohio (CCHO) and our family of ministries meets the diverse needs of hurting people with behavioral health services that transform lives, families and communities. CCHO's residential treatment facility in Wooster, OH is home to as many as 36 kids at once. In the past year, we helped 84 residents process through past trauma and build skills that will make them successful in homes and communities while enabling them to lead productive lives as adults. Our Encourage Foster Care department added 10 new families to our foster care network last year while finalizing 10 adoptions. 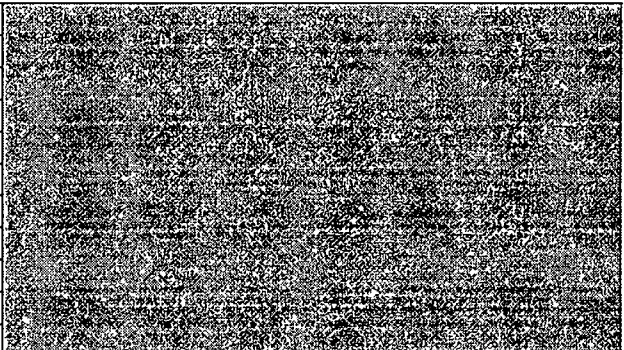
