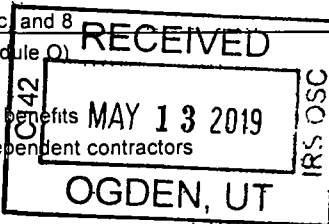




- TO COOPERATE WITH THE NATIONAL PEST MANAGEMENT ASSOCIATION AND THE VARIOUS STATE AND LOCAL PEST CONTROL ASSOCIATIONS
- TO OBTAIN AND DISTRIBUTE INFORMATION THAT WOULD BE OF VALUE TO MEMBERS OF THE PEST CONTROL INDUSTRY
- TO FURTHER PUBLIC RESPECT AND CONFIDENCE IN PROFESSIONAL PEST CONTROL
- TO FURTHER THE MUTUAL BENEFITS AND ASSOCIATIONS OF THE MEMBERS OF PI CHI OMEGA BY THE HOLDING OF MEETINGS FOR THE PRESENTATION AND DISCUSSION OF REPORTS ON THE INVESTIGATIONS AND EXPERIENCES OF THE MEMBERS IN THE FIELD OF PEST CONTROL
