Amended and Restated Articles of Incorporation

WHEREAS, Article Ninth of the Articles of Incorporation, as amended, of Mandel Supporting Foundations -- Jack N. and Lilyan Mandel Fund, an Ohio nonprofit corporation (the "Corporation"), provides that the affirmative vote of the Federation Member, and, if there are two or more Donor Members, the affirmative vote of at least one Donor Member is required to, among other things, adopt new Articles of Incorporation; and

WHEREAS, the Federation Member, through the Federation Representative, desires and each Donor Member desires to amend the Articles of Incorporation of the Corporation in its entirety.

RESOLVED, that the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety to read as follows:

FIRST: The name of the Corporation is Mandel Supporting Foundation.

SECOND: The place in the State where the principal office of the Corporation is located is Cleveland, Cuyahoga County, Ohio.

THIRD: The Corporation is organized and shall be operated exclusively for charitable, educational, or religious purposes by conducting or supporting activities for the benefit of, to perform the functions of, or to carry out the purposes of the qualified organization specified herein. Jewish Federation of Cleveland, an Ohio nonprofit corporation (the "Federation"), is so specified. An organization is a "qualified organization" for purposes of these Articles only if it is described in Section 501(c)(3) and Sections 509(a)(1) or (a)(2) of the Internal Revenue Code of 1986, as amended (hereinafter, the "Code"). If the Federation ceases to be a qualified organization, the Corporation shall be operated for the benefit of, to perform the functions of, or to carry out the purposes of such qualified organization or organizations which shall be selected by the Board of Trustees of the Corporation.

Solely for the above purposes, the Corporation is empowered to exercise all rights and powers conferred by the laws of the State of Ohio upon nonprofit corporations, including, but without limitation thereon, the right and power to receive gifts, bequests and contributions outright, in trust or in any other form; to collect dues; and to use, apply, invest and reinvest the principal and/or income therefrom or to distribute the same for the above purposes.

FOURTH: No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Trustees, officers or private individuals, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and

distributions in furtherance of the purposes set forth in Article THIRD hereof. The Corporation shall not carry on propaganda or otherwise attempt to influence legislation to such extent as would result in the loss of exemption under Section 501(c)(3) of the Code. No activity of the Corporation shall consist of participating in or intervening in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. It is intended that this Corporation shall have and continue to have the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) thereof. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by an organization (a) exempt from federal income tax under Section 501(c)(3) of the Code; (b) contributions to which are deductible for federal income tax purposes under Section 170(c)(2) of the Code; (c) bequests to which are deductible for federal estate tax purposes under Section 2055(a)(2) of the Code; and (d) gifts to which are deductible for federal gift tax purposes under Section 2522(a)(2) of the Code. These Articles shall be construed accordingly, and all powers and activities hereunder shall be limited accordingly.

FIFTH: The Members of the Corporation shall be divided into two classes: the Federation Member and the Donor Members. The respective rights of each class of Members shall be as set forth in the Code of Regulations of the Corporation. The Trustees of the Corporation shall be divided into two classes: the Federation Class and the Donor Class. The method of electing each class of Trustees shall be set forth in the Code of Regulations of the Corporation.

SIXTH: Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provisions for the payment of all of the known liabilities of the Corporation, distribute all of the assets of the Corporation exclusively for charitable, educational, or religious purposes to the organization specified in Article THIRD if it is then a "qualified" organization. If such organization is not then a "qualified" organization, such assets shall be distributed in such manner and to such "qualified" organizations as the Board of Trustees shall determine. An organization shall be deemed to be a "qualified" organization for purposes of this Article SIXTH only if at the time of the distribution of such assets it is operated exclusively for purposes described in Section 170(c)(2)(B) of the Code and is an organization described in Section 501(c)(3) of the Code. Any of such assets not so distributed shall be distributed by the court of common pleas of the county in which the principal office of the Corporation is then located, exclusively for the aforesaid purposes of the Corporation, or to such qualified organization or organizations as said court shall determine.

SEVENTH: The affirmative vote of the Federation Member and, if there are two or more Donor Members, the affirmative vote of at least one Donor Member at any annual meeting of Members or special meeting of Members shall be required to adopt or approve the following actions:

- (i) Liquidation or dissolution of the Corporation;
- (ii) Merger, consolidation or transfer of substantially all the assets of the Corporation; and
- (iii) Repeal, modification, amendment, in whole or in part, or addition to the Articles of Incorporation or Code of Regulations of the Corporation or adoption of new Articles of Incorporation or Code of Regulations.

The notice of the meeting at which any such action is to be considered shall set forth the subject of the action or actions to be approved.

EIGHTH: Any reference in these Articles to a section of the Internal Revenue Code shall be interpreted to include a reference to the corresponding provisions of any applicable future United States internal revenue law.

FURTHER RESOLVED, that each officer of the Corporation is hereby authorized and directed to execute a Certificate of Amendment to effectuate the foregoing amendment and restatement of the Articles of Incorporation of the Corporation and to file such Certificate with the Ohio Secretary of State.
