4a (Code: ) (Expenses \$ 153,892 including grants of \$ ) (Revenue \$ ) HUMAN RIGHTS ISSUE EDUCATION, SOCIAL ACTION, AND ADVOCACY PROGRAMS: Nearly 2,000 attendees, animated by Pope Francis's call "to grow in love which is courageous, generous, and real" attended the 21st annual Ignatian Family Teach-In for Justice, held in the Washington, D.C. area from November 3-5, 2018. In the midst of a shifting political landscape, the Teach-In, an annual effort of the Ignatian Solidarity Network, affirmed that, as people of faith, attendees stand in solidarity with those marginalized by injustice. Teach-in attendees represented over 150 Catholic institutions in twenty-seven states, Canada, El Salvador and Mexico, including over seventy Jesuit universities, high schools, and parishes. Not only did attendees grow in their knowledge of a wide range of social justice issues facing society today, they also had the opportunity to deepen their faith life through prayer and reflection; network with peers and colleagues from throughout the hemisphere and take action as legislative advocates. 4b (Code ) (Expenses \$ 223,617 including grants of \$ ) (Revenue \$ ) FAITH-BASED SOCIAL JUSTICE LEADERSHIP DEVELOPMENT & AFFIRMATION: ISN hosted three leadership summits for high school students and faculty across the country in Spring 2018. Named after the late Pedro Arrupe, S.J., former leader of the Jesuits internationally, the Arrupe Summits offer students and teachers the opportunity to explore the relationship between service, social justice, faith, and leadership. Over 150 students from Jesuit and partner Catholic high schools across the U.S. and Canada participated in the summits which took place in California, Ohio, and Maryland. In July, 2018, ISN hosted 38 Jesuit college and university students for a 4-day/3-night social justice leadership summit on immigration grounded in Ignatian spirituality and the values of Jesuit education. The summit provided student leaders from more than a dozen Jesuit and other Catholic schools across the country an opportunity to develop effective justice leadership skills and increase their understanding of the relationship between Jesuit mission and immigration justice (continued Schedule O).

4c (Code: ) (Expenses \$ 165,600 including grants of \$ ) (Revenue \$ ) COMMUNICATIONS AND NETWORK: The Ignatian Solidarity Network continues to grow the ways it networks, educates, and forms advocates for social justice digitally and in print materials. ISN's website (www.ignatiansolidarity.net) welcomed nearly 207,000 visitors in 2017-2018. On the site users found social justice news from the Ignatian network, moving blog posts written by a diverse range of authors-including a special series entitled "JV Reflects" featuring current Jesuit Volunteers placed domestically and internationally-and education and advocacy resources on key justice issues. ISN also had 40,000 social media followers (in total from Facebook, Twitter, and Instagram) as of June 30, 2018. Throughout Lent, the "break Forth" reflection series invited thousands of individuals to let our light "break forth like the dawn" by being the best versions of ourselves-working together to build a world in which the dignity of all people is upheld. Featured contributors included Bishop Mark Seitz, Fr. James Martin, S.J., and Sr. Norma Pimentel, M.J. (continued Schedule O).

facilitation of the Campaign for Hospitality. In its second year, the Campaign created  
opportunities for individuals and communities to engage in a culture of hospitality through  
learning, encounter and advocacy. Activities included a national "Valentine's Day" campaign to  
send a message of "love" for immigrant brothers and sisters to members of Congress, asking  
them to work toward policies that demonstrate respect for the inherent dignity of all  
people, including immigrants. ISN also co-facilitated a national meeting of immigration leaders

from across the Jesuit network, the Jesuit Migration Network, to discuss ways of more

effectively working toward humane migration policies. Hundreds of educators at Jesuit institutions across the US joined in a series of networking calls to discuss ways that individual institutions and the broader network could support undocumented persons, including students, parishioners, and their families. ISN brought advocacy and solidarity with immigrants and refugees into the public square with t-shirts and signs that could be found at rallies and events throughout the country.

Form 990, Part III, Section 4b. In June 2018, ISN hosted twenty-seven staff from twenty different Ignatian network colleges and universities for an Immersion Coordinators Summit. The gathering serves as an integral space for these student affairs and ministry professionals to share best practices and network to develop ethical and holistic immersion program experiences. Also in 2018, ISN recognized Fr. Greg Boyle, S.J., founder of Homeboy Industries, with the Robert M. Holstein Award. Named after the late ISN co-founder Bob Holstein, the award honors those who have demonstrated a significant commitment to leadership or social justice. Previous award winners included Patricia McGuire, Fr. Michael Garanzini, S.J., Sr. Carol Keehan, D.C.; Fr. Jim Connor, S.J.; Fr. Charlie Currie, S.J.; Fr. Stephen Privett, S.J.; Fr. Donald MacMillan, S.J.; and Sr. Helen Prejean, C.S.J. ISN also honored two young alumni with the Moira O'Donnell Emerging Leaders Award, bestowed on graduates of Jesuit universities ages 23-33 who have demonstrated significant social justice leadership in their communities. The 2018 honorees were Annie Boyd Ramirez (Marquette University, 2007) and Andrew Lunetta (Le Moyne College, 2012).

Form 990, Part III, Section 4c. Over 2,000 subscribers received the "Rise Up" reflections via e-mail daily with thousands more reading them directly on the ISN website. In partnership with Jesuit Volunteer Corps and Jesuit Volunteer Corps Northwest, ISN hosted hundreds of young adults at Solidarity on Tap events across the country, in cities like Seattle, Philadelphia, San Francisco, Philadelphia, New York City, and Baltimore. Solidarity on Tap is a simple gathering at a local pub for socializing and social justice that welcomes Jesuit school alumni, Jesuit parish members, current & former Jesuit Volunteers, Ignatian Volunteer Corps members, Jesuit institution staff, Jesuits and friends of the Ignatian network.
