Proceeds from deaccessions or insurance recoveries are reflected as increases in the appropriate net asset classes. The Foundation received proceeds of \$6,733 from deaccessions during the year ended June 30, 2018 and \$365 during the year ended June 30, 2017.

Part III, 4: The Foundation owns certain historical fashion items. The Kent State University Museum maintains custody of these items which provide the basis for the museum's exhibits and an academic resource for Kent State University.

Part V, 4: The endowment funds of the Foundation are invested with the purpose of using the earnings to support the needs and priorities of Kent State University.

Part X, 2: Pursuant to determination by the Internal Revenue Service, the Foundation is exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code. The Foundation recognizes a benefit only if it is "more-likely-than-not" that the tax position would be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount of tax benefit that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more-likely-than-not" test, no tax benefit is recorded. Management has concluded that they are unaware of any uncertain tax benefits or liabilities to be recognized at June 30, 2018 or

2017. The Foundation would recognize interest and penalties related to unrecognized tax benefits in interest and income tax, respectively.
