This body reviews and approves research projects for funding submitted by universities worldwide. On a quarterly basis, Hill solicits contributions from former members of Roses Inc through direct mail (Note as of June 30, 2010, Roses Inc ceased office operations. Former members are being encouraged to make contributions to Hill.) Hill's 6/30/18 percentage of public support is 13.57%. Thus Hill is not publically supported under the 33 1/3% support test. However, Hill's public support is 10% or more of its total support, it is attempting to attract additional public support and it has a broad, representative governing body. Thus Hill should qualify for public charity status under the facts and circumstances test of IRC Sec 170(b)(1)(A)(vi).
