The program operates four days a week at seven different Chicago public high schools which include the following high schools: Robeson, located in the Englewood community, Hyde Park, located in the Hyde Park community, Julian High School, located in south Chicago, Simeon, located in West Chatham, John Hope High School, located in south Chicago, Farragut, located in the Little Village community, and Simpson, located in the Little Village community. TPI aims to prevent teen parents from dropping out of high school, while preventing secondary teen pregnancies and reducing the incidence of child maltreatment for their young children. It also promotes school readiness for the at-risk children.

Early Head Start (EHS) targets low-income pregnant women and families with children from birth through age 3, most of whom are at or below the federal poverty level or who are eligible for services under the Individuals with Disabilities Education Act. The Early Head Start program utilizes the home-based service option, which includes weekly 90-minute home visits and two group socialization activities per month for parents and their children. Home visitors are required to have knowledge and experience in child development and early childhood education, principles of child health, safety, and nutrition, adult learning principles, and family dynamics.
