The amended bylaws establish the Governance Committee consisting of the College's immediate past president, the Foundation's immediate past president, three at-large members of the Board of Regents and two at-large members of the Board of Trustees to be selected by the College and Foundation presidents. The College's immediate past president will serve as chair and the Foundation's immediate past president shall serve as the committee co-chair. The Governance Committee has the authority of the Board of Trustees subject to resolutions and rules of the board.
