Research Advance the understanding and treatment of lung diseases by supporting and participating in scientifically meritorious research. The goal is to help improve the quality of life for those living with lung disease. Research on a wide range of lung disease issues is covered including asthma, lung cancer, COPD, interstitial lung disease (including pulmonary fibrosis) and acute respiratory distress syndrome (ARDS). Respiratory Health Association aims to fund the most promising research and strives to foster greater collaboration among researchers and among organizations that support lung disease research. Through the development of partnerships with other research organizations, Respiratory Health Association is able to maximize research awards and make every dollar raised go farther. Research funded by Respiratory Health Association helps scientists diagnose lung disease earlier, discover causes and find cures. Past research projects have included efforts at University of Chicago, University of Illinois at Chicago, Rush University Medical Center and Northwestern University. Respiratory Health Association also engage stakeholders in citywide research projects and serves as an advisor on research projects to improve outcomes for people living with lung disease.
