Surgeon continues to showcase the talent of more than 50 years that his legacy trainees have led the nation and the world transplant community in the field of Solid Organ Transplantation Dr Najarian is widely-recognized as the worlds leading educator of organ transplant fellows whose numbers now exceeds 218 from the University of Minnesota Veterans of Foreign Wars and its Ladies Auxiliary Cancer Research Center under the direction of the Board of Directors, provides funding for the Veterans of Foreign Wars and its Auxiliary Surgical Oncology Surgery Research Award at the University of
