IPHCA provides education, training and technical assistance to potential and existing community health centers (CHCs), including its member health centers who operate over 370 sites through a cooperative agreement with the Health Resources and Services Administration (HRSA) Through this agreement, IPHCA conducts various statewide/regional educational offerings and technical activities to help assist potential and existing health centers meet the HRSA Health Center program requirements, to enhance the operation of health care services, to assist in the recruitment and retention of professional clinical staff, to help develop and maintain information systems, and to promote linkages between CHCs and related organizations and agencies

Form 990, Part III, Line 4b:

In a cooperative agreement with the Illinois Department of Public Health (IDPH) Office of Policy, Planning, and Statistics, IPHCA conducts recruitment visits to health professions training programs and schools to encourage employment in Community Health Centers (CHCs), promote the National Health Service Corp (NHSC), and educate health profession students about loan repayment and scholarship opportunities. IPHCA provides assistance to CHCs around recruitment and retention of their clinical staff. Through IPHCA's in-house recruitment services, health center jobs are distributed to candidates interested in CHC employment. IPHCA also works with IDPH to gather data and evaluate, prepare and submit shortage designation applications for Health Professional Shortage Areas (HPSAs) and Medically Underserved Areas/Populations which are used in conjunction with NHSC and grant awards respectively. IPHCA assisted in the recruitment of 35 clinicians during fiscal year 2018.

Form 990, Part III, Line 4c:

Through a grant partnership with the Illinois Department of Public Health (IDPH) Office of Health Promotion, IPHCA has promoted the Chronic Disease and School Health Interventions Project since 2015. This is a CDC-funded initiative to facilitate chronic disease awareness and outcomes at Federally Qualified Health Centers (FQHCs), specifically diabetes and hypertension, through survey of electronic health records system capabilities, increasing referral of eligible patients to community-based chronic disease self-management education programs, and enhancing quality improvement processes in health systems. IPHCA provides quality improvement technical assistance to help the FQHCs improve electronic health records for follow-up of patients with high blood pressure and diabetes, provider reminder systems, referral mechanisms and clinical decision support. Through this partnership, IPHCA has established relationships with the Illinois Health and Hospital Association, Illinois Pharmacy Association and the Association of State and Territorial Health Officials while working on a statewide diabetes planning project.
