FROM JUNE THROUGH AUGUST, TEACHERS CORRESPOND WITH STUDENTS AND SEND THEM BOOKS IN THE MAIL. RESEARCH HAS SHOWN THAT ECONOMICALLY DISADVANTAGED AND/OR STRUGGLING READERS, ENGAGE IN VERY LITTLE READING DURING THEIR SUMMER VACATION. THIS LACK OF READING, RESULTS IN CONSIDERABLE SUMMER READING LOSS. STUDENTS OFTEN LOSE FROM ONE TO THREE MONTHS OF READING ACHIEVEMENT. BY KEEPING THESE STRUGGLING READERS ENGAGED IN READING, THEY WOULD BE ABLE TO MAINTAIN THE READING GROWTH THEY HAD ATTAINED DURING THE SCHOOL YEAR.
