What is the organization's primary exempt purpose?
Beyond Blue Corporation is organized to coordinate and develop operational activities of the University of Kentucky for its health care programs that will be conducted outside of the Commonwealth of Kentucky, while supporting the University's mission of teaching, research, and service. As this update, an advanced practice provider provided patient care services at Cincinnati Children's Hospital Medical Center on four (4) days. In addition, an physician specializing in pediatric electrophysiology provided 26 days of services at Cincinnati Children's Hospital Medical Center. No other clinical services were provided in any of the seven (7) states in which the Corporation has been authorized to conduct business. The University of Kentucky (University) continues clinical outreach opportunities with providers in Ohio, Tennessee, Indiana, and West Virginia.
