The Foundation exists to raise, receive and administer donations for Delta College by building relationships with donors and direct fundraising efforts. All contributions to the Foundation are transferred or spent to benefit the College's students, educational programs, staff development, capital projects or other critical financial needs.

Contributions received for instructional purposes included cash, equipment and classroom supplies. These donations were transferred to Delta College to enhance educational programs and provided scholarships and awards. The Foundation also used funds to publish and distribute an informative magazine highlighting Delta College success stories, programs and events available to residents of the surrounding communities. These contributions benefitted the entire college community of 13,300 students and staff, as well as residents of the entire Great Lakes Bay Region by providing valuable information of the opportunities available to them.

4b (Code:) (Expenses \$ 505,894 including grants of \$ 505,894) (Revenue \$)
Contributions for the Delta College Endowment Fund were transferred to the College for investment. Income generated by the Endowment Fund provided approximately 380 scholarships and awards during the year. It also supported numerous programs and projects such as the Possible Dream Program, the Presidents Scholar Program, STEM Education for Science, Technology, Engineering and Math and several Teaching Chairs. These programs benefitted the entire Delta College community of 13,300 students and staff, as well as residents of all ages living in the surrounding communities.

4c (Code:) (Expenses \$ 13,937 including grants of \$ 13,937) (Revenue \$)
Contributions for non-academic assistance were used to provide emergency funding to enrolled students who needed help "outside of the classroom" so they could be successful in the classes they were already attending. Students received financial assistance for rent, utilities, transportation and groceries. Non-academic assistance benefitted approximately 180 students.

The indemnification changes also needed to be reflected in the Articles of Incorporation. As that document was revised, the Foundation also added a more detailed description of its charitable purpose, as required by the State of Michigan to meet IRS regulations. These revisions were approved by the Board of Directors in September 2018, then filed and accepted by the State of Michigan Corporations Division.

Form 990, Part VI, Line 11b:

The entire Foundation Board of Directors reviews the financial statements quarterly throughout the year. At the end of the year, the Executive Director distributes the completed Form 990 to the members of the Board who serve on the Finance Committee. The committee members are expected to review the entire Form 990 and the required schedules prior to meeting with the Executive Director, the Treasurer and the Accountant, who prepares the Form 990. This meeting provides an opportunity to question, amend, if necessary, and approve the content of the Form 990 prior to submitting it to the IRS. The Finance Committee reports back to the full Board of Directors at the next Board meeting.
