Molecular Physiology and Pharmacology of ATP1A3 Mutations in AHC: \$250,000 grant awarded to Dr. Alfred George, Jr. at Northwestern University and Dr. Kevin Ess at Vanderbilt University to investigate the functional consequence of AHC gene mutations, to identify drugs or drug-like compounds with potential therapeutic effects in restoring normal gene function, and to develop advanced human cell models of AHC based on state-of-the-art induced pluripotent stem cell technologies.

Acceleration project at Vanderbilt University: This is a continuation of the project that was started last year. The project will generate and validate highly specific antibodies targeted against the alpha 3 and alpha 2 subunits of the Na/K ATPase. This will greatly accelerate our research as we will be able to accurately assess levels of these important proteins. We expect them to not only work for our human stem cell based models of AHC, but given the extremely high sequence homology, to also be useful for mouse models of AHC/RDP/CAPOS as well.
