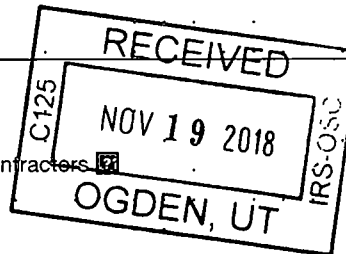

Ice Dance Weekend. Annual two-and-a-half day Ice Dance Weekend held in August 2017. Approximately 15 skaters participated. Event

Includes several social dance sessions and two or more instructional workshops.

Expenses = 3,392

Club Ice and Membership Events. There were 10 club ice sessions during the year. About 14 skaters participate at each. These sessions give skaters the opportunity to practice and develop their skating and encourages a spirit of community among Club members. This includes ice for the annual exhibition held before the Club's competition. The exhibition allows skaters to practice their programs in front of friends and family prior to the competition. Approximately 30 skaters participated in the exhibition.

Expenses = 2,400

Test Sessions. There were two test sessions during the year. 11 Club members passed a total of 15 tests. Tests allow skaters to test for appropriate skating levels as recognized by U.S. Figure Skating. These tests also allow skaters to become eligible for qualifying competitions. Expenses = 1,320.

Education. The Club hosted a Parent Education Seminar for parents of our Learn to Skate skaters. Approximately 10 parents attended.

Also, one board member was sent to U.S. Figure Skating's annual meeting. This provided that board member with the opportunity to learn about new figure skating programs. Expenses = \$625.
