WHEN THERE IS A QUESTION AS TO WHETHER A CONFLICT EXISTS, THE MATTER SHALL BE RESOLVED BY VOTE OF THE BOARD, EXCLUDING THE PERSON(S) CONCERNING WHOSE SITUATION THE DOUBT HAS ARISEN. THE OFFICIAL MINUTES OF THE BOARD SHALL REFLECT THAT THE CONFLICT OF INTEREST WAS DISCLOSED AND WHETHER OR NOT THE INTERESTED PERSON(S) PARTICIPATED IN THE FINAL DISCUSSION AND VOTE.
