We provide fraud prevention education to at-risk consumer populations, specifically senior citizens and the military community. We also offer our community-free Secure Your ID shredding events. Our fraud prevention initiatives include our long-standing partnership with law enforcement representatives in both Minnesota and North Dakota (known as the Coalition Against Marketplace Fraud).
