The BOT then acts as a holding company Board, synthesizing and reconciling each entity's programs and budgets into a system-wide strategic plan. This structure of governance produces a significant number of trustees, governors and directors. Sanford Health of Northern Minnesota, a wholly-controlled subsidiary of Sanford and Sanford North, is the sole member of the organization. Certain actions of the Board of Directors of the organization are subject to member approval.
