The Arts Activities Support program offers grants of up to \$10,000 in project support for metro groups that offer quality arts activities in any discipline to communities within the seven-county metro area. Grant requests may include costs for artists and other personnel, postage, supplies, equipment, printing, travel and other expenses necessary to carry out the project. In FY2018, MRAC received 285 applications requesting \$2,735,862, and awarded 152 grants totaling \$1,468,259 in this program. The Community Arts grant program provides grants of up to \$5,000 in project support for metro groups that offer quality arts activities in any discipline to communities within the seven-county metropolitan area. The program utilizes a block grant system to distribute funds. Each of the counties in MRAC's service area Anoka, Carver, Dakota, Hennepin, Ramsey, Scott and Washington receives a block of funds designated for arts activities occurring within that county. Community Arts is intended for community based and volunteer groups, smaller, established arts groups, and newly formed groups or first-time initiatives. Grant requests may include costs for artists and other personnel, postage, supplies, equipment, printing, travel and other expenses necessary to carry out the project. In FY2018, MRAC received 208 applications requesting \$997,874, and awarded 130 grants totaling \$621,675 in this program. The Arts Learning program provides grants of up to \$10,000 for high-quality, arts education for Minnesotans of all ages to develop knowledge, skills, and understanding of the arts and/or learning through the arts. In FY2018, MRAC received 140 applications requesting \$1,312,075, and awarded 49 grants totaling \$477,874 in this program. The Organizational Development program provides grants of up to \$10,000 for projects designed to strengthen the management or administration of nonprofit arts groups. Such projects must 1) advance the mission of the group and 2) have the potential for significant or long-term impact. In FY2018, MRAC received 79 applications requesting \$772,327, and awarded 30 grants totaling \$293,545 in this program. The Capital grant program provides funds of up to \$10,000 to purchase equipment and related supplies and services, or to make capital improvements. Such activities must 1) advance the mission of the group and 2) have the potential for significant or long-term impact. In FY2018, MRAC received 41 applications requesting \$342,365, and awarded 18 grants totaling \$144,222 in this program. The ADA Access Improvement Fund is operated in partnership with VSA Minnesota, a nonprofit organization specializing in arts programs and services for people with disabilities. The program provides grants for metro groups of up to \$7,500 for projects with significant or long-term potential to involve more people with disabilities as participants or patrons in arts program in the 7-county metropolitan area. In FY2018, MRAC paid VSA Minnesota a grant of \$195,000 for administration and grants for this program. The Management Consulting Fund program offers grants of up to \$1,750 to provide consultants for groups to complete small projects to strengthen the management or administration of the group. Such management consulting projects must 1) strengthen the management or administration of nonprofit arts groups, 2) advance the mission of the group, and 3) have the potential for significant or long-term impact. In FY2018, MRAC received 84 applications requesting \$145,250, and awarded 35 grants totaling \$60,980. The Management Training Fund program offers grants of up to \$600 to provide training funds for the staff and volunteers of nonprofit arts groups to attend management workshops, seminars or conferences. In FY2018, MRAC received 47 applications and awarded 46 grants totaling \$7,442. The Next Step Fund is MRACs grant program for individual artists, providing grants up to \$5,000 to professional artists in any discipline for the purpose of career development and artistic achievement. The Next Step Fund is funded entirely by the McKnight Foundation. In FY2018, MRAC received 505 applications and awarded 36 grants totaling \$179,200. MRAC also provides skill-building trainings for administrators of small arts organizations at no charge to participants in areas such as marketing, finance, fund-raising, and governance. In FY2018, MRAC provided 38 trainings for 554 participants. Additionally, MRAC also provides grant workshops for prospective applicants prior to each program deadline. Participants learn about the grant program, application process, and how to write an effective MRAC grant application. In FY2018, MRAC provided 29 grant workshops for 307 participants.
