CHARACTER AND SERVICE LEARNING GRANTS AS A RESULT OF THE FOUNDATION DOLLARS, STUDENTS HAVE EXPERIENCES TO SERVE THE COMMUNITY WHILE BUILDING CIVIC RESPONSIBILITY, SOCIAL AND ACADEMIC SKILLS. THESE EXPERIENCES DEEPEN AND EXTEND CLASSROOM INSTRUCTION, ASSISTING STUDENTS TO BUILD LEADERSHIP SKILLS AND RELATIONSHIPS AS THEY WORK TOWARD A COMMON GOAL. THE FOLLOWING K-12 STUDENT EXPERIENCES WERE A FEW OF THE HIGHLIGHTS DURING THE 2017-18 SCHOOL YEAR: 6TH GRADE SERVICE LEARNING FAIR, RECESS ROCKS MENTORING OPPORTUNITIES FOR INTERMEDIATE AND HIGH SCHOOL STUDENTS, AN AP ENVIRONMENTAL SCIENCE SERVICE LEARNING PROJECT, AND COORDINATION WITH ORONO YOUTH IN ACTION DURING 2017-2018. ADDITIONAL GRANTS WERE PROVIDED IN SUPPORT OF SCHOLARSHIPS, STEM LEARNING, ARTS EDUCATION, LEADERSHIP SYMPOSIUMS, AND TEACHER RETIREMENT AND RECOGNITION. MATH CURRICULA TRAINING AT THE END OF 2016-2017, \$125,000 WAS RAISED AS TEMPORARY RESTRICTED FUNDS FOR MATH CURRICULUM INSTRUCTION AND SUPPORT FOR GRADES K-12 AT ORONO SCHOOLS. TEACHER TRAINING AND DEVELOPMENT THIS GRANT WAS FULLY AWARDED DURING THIS FISCAL YEAR ENDING 2018. THESE FUNDS PROVIDE SUPPORT IN TWO KEY AREAS: PROFESSIONAL DEVELOPMENT AND TRAINING FOR 80 TEACHERS IN GRADES 3-9 AS WELL AS ADDING A MATH SPECIALIST POSITION TO PROVIDE ADDITIONAL HANDS-ON DIRECT SUPPORT TO TEACHERS AND STUDENTS. THE NEW MATH CURRICULUM AND MORE EFFECTIVE INSTRUCTION METHODS HELP STUDENTS DEVELOP A MATH MINDSET, TEACHING THEM TO THINK MORE FLEXIBLY WITH NUMBERS AND COMMUNICATE THEIR THINKING IN VARIOUS WAYS, LEADING TO A DEEPER UNDERSTANDING AND EVEN HIGHER OUTCOMES FOR ALL STUDENTS. THE DISTRICT PLANS TO EXPAND THE NEW MATHEMATICS CURRICULUM TO GRADES 10-12 IN 2018 AND BEYOND. AS THE NEW MATH CURRICULUM CONTINUES TO BE IMPLEMENTED AT THE UPPER GRADE LEVELS (POST ALGEBRA 1), THERE WILL BE ADDITIONAL PROFESSIONAL DEVELOPMENT REQUIREMENTS AND A CONTINUED NEED FOR A DISTRICT MATH SPECIALIST. THESE FUNDS WILL OFFER THE SUPPORT NECESSARY TO MAKE SUBSTANTIAL AND RAPID IMPROVEMENTS TO MATHEMATICS TEACHING AND ASSURE THAT THE CURRICULUM IMPLEMENTATION IS SUPPORTED BY ROBUST PROFESSIONAL DEVELOPMENT. DONORS SUPPORTED THIS INITIATIVE ON THE BELIEF THAT ALL STUDENTS CAN AND SHOULD ATTAIN HIGH LEVELS OF MATHEMATICAL LEARNING THROUGHOUT THEIR EXPERIENCE IN THE ORONO SCHOOLS. THE ORONO FOUNDATION FOR EDUCATION IS IN THE THIRD YEAR OF A 5-YEAR STRATEGIC PLAN TO INCREASE THE FUNDRAISING CAPACITY OF THE COMMUNITY AND MAXIMIZE THE GRANT POTENTIAL TO THE ORONO SCHOOLS THROUGH ANNUAL, EXCELLENCE, ENDOWMENT, AND CAPITAL / INFRASTRUCTURE CAMPAIGNS. THIS PROCESS IS GUIDED BY A MEMORANDUM OF UNDERSTANDING (MOU) WHICH WAS DRAFTED AND APPROVED BETWEEN THE ORONO FOUNDATION FOR EDUCATION AND THE ORONO SCHOOL DISTRICT IN 2016. THE PURPOSE WAS TO CLEARLY IDENTIFY THE ROLES AND RESPONSIBILITIES OF EACH PARTY AS THEY RELATE TO THE ONGOING FUNDRAISING AND PHILANTHROPY EFFORTS FOR THE ORONO SCHOOL DISTRICT AND COMMUNITY. PARTICULARLY, THIS MOU DEFINES THE PROCESS, VALUES, AND ACTIVITIES OF BOTH PARTIES IN A COMPREHENSIVE AND COORDINATED ONGOING FUNDRAISING EFFORT. THE MEMORANDUM IS INTENDED TO MAXIMIZE THE MUTUAL FUNDRAISING CAPACITIES OF THE FOUNDATION AND THE DISTRICT TO REALIZE THE MISSION OF EMPOWERING ALL STUDENTS TO ACHIEVE THEIR HIGHEST POTENTIAL AND ENSURE THE TRADITION OF ACADEMIC EXCELLENCE. THIS VISION HAS NECESSITATED A STRATEGIC RE-POSITIONING WHICH INCLUDES INVESTMENT IN ADDITIONAL CAPACITY RESOURCES INCLUDING PERSONNEL AND CONTRACTED PROFESSIONAL SERVICES. THESE INVESTMENTS WILL ALLOW THE ORGANIZATION TO EXPONENTIALLY INCREASE ITS GRANT FUNDING IN FUTURE YEARS IN SUPPORT OF ORONO SCHOOLS' EDUCATIONAL OPPORTUNITIES FOR STUDENTS. THESE INVESTMENTS PUT INTO PLACE THE RESOURCES NEEDED TO ENSURE THE ORGANIZATION'S ABILITY TO SUPPORT ORONO SCHOOLS AND STUDENTS IN A MUCH LARGER AND SIGNIFICANT WAY IN THE YEARS TO COME. FURTHERMORE, AS THE FOUNDATION EXPANDS TO MEET THE VARIOUS TYPES OF FUNDRAISING GOALS AND ACCEPTS DONATIONS, INCLUDING ENDOWMENT AND TEMPORARY RESTRICTED FUNDS (IE THE EXCELLENCE FUNDS), THESE DONATIONS ARE NOT INTENDED TO BE AWARDED ANNUALLY. IN THE CASE OF THE EXCELLENCE FUNDS, THESE GRANTS WILL BE AWARDED AS REQUESTED BY THE DISTRICT. IN 2017-2018, \$1,308,416 WAS RAISED IN SUPPORT OF THIS EXPANDED VISION OF THE FOUNDATION. THESE INVESTMENTS ARE FOR FUTURE CAPITAL IMPROVEMENTS FOR THE CAMPUS AND BUILDINGS. THESE ARE RESTRICTED FOR FUTURE GRANTS OVER THE PAST 18 YEARS, MEMBERS OF THE ORONO COMMUNITY HAVE GENEROUSLY CONTRIBUTED TO THE ENDOWMENT FUND. DUE TO THESE DONATIONS AND STRONG MARKET RETURNS, OUR ENDOWMENT FUND BALANCE AT THE END OF THIS FISCAL YEAR WAS \$1,175,856 WHICH INCLUDES \$11,500 IN CONTRIBUTIONS MADE THIS YEAR. THE ORONO FOUNDATION FOR EDUCATION MAY NOW CHOOSE TO DRAW A PERCENTAGE OF THESE EARNINGS TO PROVIDE ON-GOING, STRATEGIC FINANCIAL SUPPORT TO THE ORONO SCHOOL DISTRICT.
