<b>Part II, Community Building Activities</b>	<p>Economic Development Mercy works with such groups as the Iowa City Area Chamber of Commerce and Iowa City Area Development Group to support the business community, welcome innovation to the area, and develop the workforce. Community Support Mercy has provided support to United Way of Johnson and Washington Counties for more than 30 years, holding a campaign every fall to support it. Mercy also supports financially and with colleague time, community agencies such as Iowa City Hospice, Free Medical Clinic, NAMI (National Alliance for the Mentally Ill), American Cancer Society, School-Based Health Clinics located in three of the Iowa City Community School Districts public schools, and so on. Mercy also provides staff to provide first aid at community festivals such as Arts Fest, Jazz Fest and Soul Fest, and at the Johnson County Fair. Mercy continues to be a community leader in ensuring that fewer people experience food insecurity within Johnson County and the State of Iowa. Mercy contributes regularly to Table to Table, a local organization that collects wholesome, edible food from donors (grocery stores, restaurants, and Mercy Iowa City) and redirects it to food pantries and meal sites in the county. Mercy is also a lead organization for Thanksgiving in July, an annual summer food drive whose goal is to fill food pantries at a time of year when they have fewer donations and children are out of school, not receiving free and reduced breakfast and lunch. This program was started at Mercy Iowa City in 1995 and has grown to include many other sites in the State of Iowa including Des Moines, Dubuque and the Quad Cities. Environmental Improvements Mercy has been a good neighbor by maintaining its buildings and landscaping at a high level. Mercy also pursues extensive recycling (including newspapers, office paper, magazines, plastics, batteries, cooking oil, construction materials and more) and programs that reduce energy consumption. Mercy is expanding its recycling program to make it easier for colleagues and visitors to participate throughout the hospital. Leadership Development and Training of Community Members Mercy lends support to the annual Community Leadership Program of the Iowa City Area Chamber of Commerce, a nine-month leadership development program for 24 individuals who are increasing their professional and personal commitment to the community. Mercy sponsors a class member each year and participates actively in the health care day of education. Mercy also supports an active Clinical Ladder program for nurses, offers Continuing Education Credit (CEU) courses and conferences open to medical professionals across the State on a regular basis, such as those tailored to Emergency Care, Hospitalist care and Nursing care. Mercy also offers a location for CEU courses for the local Honoring Your Wishes initiative which encourages all adults to have Advance Directives that are current and reflect their wishes. The CEU courses train individuals to become certified counselors to help individuals with their Advance Directives, and to train certified counselors to assist with IPOST which is the Iowa version of the national POLST directive, a medical order for those with terminal conditions. Honoring Your Wishes is the program used at Mercy, and the hospital offers free assistance to anyone in its service area who needs it to complete their documents. Coalition Building Mercy is involved in many ways with local citizens and groups that are working to afford all members of our community a good quality of life and to improve overall quality of life. Mercy is a co-sponsor of the Johnson County SAFE Kids Coalition whose mission is to prevent or reduce preventable injuries to children from birth to age 14. SAFE Kids promotes the correct use of child safety restraints in vehicles, bicycle helmets, and safety education to prevent falls, burns, poisoning and more. Mercy is also a lead partner of Safety Village, a two-week summer safety camp for children aged 5-7 held in a miniature village on the grounds of one of our local elementary schools. Each summer, 200 children participate in classes and safety education with local EMS, police, sheriffs and others. Mercy is also a lead partner in a new Health and Rural Safety of Eastern Iowa initiative which works to reduce preventable injuries in the agricultural community such as heavy equipment, large animal, pesticides and more. This partnership also seeks to increase health screenings and referrals to primary and specialty care for this population, that includes Anabaptist, and provide education to improve health. Some of this is accomplished through youth safety camps, FFA (Future Farmers of America) and 4-H programs, county fairs, community events and in cooperation with churches.</p>

Additionally, Mercy Hospital did not update the Amounts General Billed ("AGB") percentage for tax year 2016 that was attached to the Financial Assistance Policy as required under IRC Section 501(r)(4). Upon notification of this error, Mercy Hospital has corrected the error and posted an updated copy of the Financial Assistance policy with the current year AGB attached to the policy. Mercy has plans in place to review each person who received financial assistance that may have been impacted by the AGB overstatement year over year and refund any monies due. To Mercy Hospital's knowledge, no individual who was eligible under Mercy Hospital's financial Assistance policy was billed an amount or otherwise impacted by this error.
