THE ORIGINAL UNIVERSITY FOUNDATION AND THE IOWA STATE UNIVERSITY ACHIEVEMENT FUND WERE BOTH PREDECESSOR ORGANIZATIONS TO THE ISU FOUNDATION AND CONTINUE TO EXIST AS SEPARATE LEGAL ENTITIES. ANY ACTIVITY RELATING TO THE TWO PREDECESSOR ORGANIZATIONS IS TRANSFERRED IMMEDIATELY INTO THE ISU FOUNDATION. FOR FINANCIAL STATEMENT PURPOSES, ALL THREE ORGANIZATIONS ARE REPORTED ON A COMBINED BASIS DUE TO A COMMON BOARD OF DIRECTORS, COMMON MANAGEMENT, AND THE COMMON MISSION TO SUPPORT THE UNIVERSITY. The ISU Facilities Corporation is a related tax exempt organization, established primarily to issue revenue bonds to assist in funding construction projects at the university. The bonds are payable solely from the lease payments paid by the University for the facilities and upon repayment of the bonds, ownership of the facilities transfer to the University. For financial statement purposes, the ISU Facilities Corporation activity is reported in Iowa State University's financial statements.
