Professional Care While our care and outcomes must be best in the business, so must our customer service to our patients, to our referral sources, and to the state of Colorado. We made a commitment to act and look professional at all times. That included everything from our email signatures and voicemail messages to our interactions with patients to our dress and appearance. Process Improvements Our service delivery also needed streamlining. Our leadership team did a complete audit of every service and program to get a better understanding of what we are doing well and where efficiencies are still needed. We looked for ways to increase productivity while not overshadowing quality. We honed in on utilization management, medical necessity, diagnoses, and improved documentation and treatment planning. Structure In order to be prepared for the future, our structure also needed finetuning to ensure the right people had oversight of the right areas.
