Facts And Circumstances Test

Soroptimist International of Kansas City (SIKC) is a local nonprofit club that is a part of a global volunteer organization that improves the lives of women and girls through programs leading to social and economic empowerment. We do this by supporting our community nonprofit organizations with likeminded missions through hands on volunteering, awards and recognition programs, and generous grants. This year alone, over \$58,000 was distributed to 14 local community organizations from across the city to support multiple women's programs and causes. These organizations include, providing funding to Harvesters to give backpacks of food to school children so they will have food on the weekends, funding to Safe Home, Mothers Refuge, reStart, Salvation Army, Keeler Women's Center, and Hope House so vulnerable women and girls will have safe housing and basic needs met. Application for these awards is open to all community organizations with programs that further the Soroptimist mission of improving the lives of women and girls in the greater Kansas City area. SIKC has restructured its fundraising efforts to try and expand its reach into the community and to a more diverse group of supporters. During May 2018, SIKC held a successful golf tournament with strong support in the community. Funds raised were used by the club to support its vision of a global volunteer organization by sending \$9400 to our sister club in Zimbabwe, Harare to help a group of destitute aged build a farm that would not only feed them but provide income to continue the farm for years to come. The 2017-2018 Live Your Dream Awards, which aid female heads of households seeking to expand their opportunities through education, totaled \$6,000. SIKC has provided services and resources to the community for many decades, while the Foundation has been in existence for sixty years. We continue to try and broaden our membership which is made up of women of all ages from diverse social, cultural and ethnic groups and many different businesses and professions. Our Board Members are strong community leaders, and professionals who are lawyers, educators, non-profit employees, healthcare providers and caring community volunteers. Yearly we critically assess the community needs and make decisions regarding where SIKC can best assist and make an impact in meeting those needs. We look for great volunteering opportunities for our club members and our Foundation Board Members. We have recruited new members during our volunteer projects. We realize it is important to be out in the community we serve.
