In 2017-2018, we received \$6,000 and also had \$1,476 remaining from 2016-2017 for total disbursements of \$7,476. Hassing Scholarship recipients must also fill out paperwork showing the need and their compliance with the requirements of the scholarship endowment fund set up. The Internal Relations/Oversight Committee reviews all Hassing Scholarship applications to determine their compliance with the requirements and makes a recommendation to the full Board of Directors. We offer up to 2 \$1,000 Hassing Scholarships per year per the terms of the endowment fund set up.
