For charitable, scientific & educational purposes primarily promoting public/private partnership, advancing research and technology development, including entrepreneurship The following were NDSU Research & Technology Park's unique programs in 2017 Since 2010, the RTP has partnered with the NDSU to host educational events and networking opportunities for NDSU students focused on innovation and entrepreneurship The purpose is to increase student awareness for entrepreneurship, encourage students to consider entrepreneurship as a career choice, educate students on resources available for entrepreneurs and engage the current entrepreneur and business communities with students This was the ninth year the Innovation Challenge program has been held and the program continues to evolve This year the format of the competition was changed to fit into a semester to allow professors to incorporate the challenge into their curriculum The competition focused on the innovative work being done on campus by NDSU students The Innovation Challenge activities were held throughout the spring semester to allow for more engagement with the students Students prepared innovation proposals, visual displays and oral presentations for judging Criteria for the three sections focused on all aspects of innovation The winners were announced at the awards luncheon on April 17, 2018 There are nine student teams interested in starting a company At the Technology Incubator, the Organization continues to work hard to create an entrepreneurial culture that fosters innovation and encourages ingenuity This was accomplished by providing coaching and mentoring services and networking events In 2014, the Organization became an administrator for the State of North Dakota Department of Commerce Innovate ND program The RTP is responsible for assisting the companies with developing a business plan, creating and executing a budget for Innovate ND funds and providing the company with coaching and mentoring Approximately 12 new clients were provided with services through this program this past year along with the clients currently enrolled Since the program started the Organization has assisted 84 companies through the program In June of 2008, the Organization invested in NDSU Research Park Ventures, LLC The partnership was incorporated for the purpose of operating a renaissance fund corporation for the City of Fargo The purpose of the fund is to raise funds to be used to make investments in zone and research park projects and to assist in financing of renaissance zone projects in a manner that will encourage capital and real estate investment in the City of Fargo which, in return, will encourage the expansion of technology based entrepreneurial business development The project zones are located in downtown Fargo and in the NDSU Research & Technology Park at North Dakota State University The Organization hosted Lunch & Learns for its incubator clients and Innovate ND clients This year's topics included how to use social media to your advantage and to selectively target your customers and was followed up with an in-depth look at social media analytics and how to evaluate and alter your social media strategies One of the incubator clients presented overview on the value of appropriate IT strategy During Startup Day Across America, North Dakota Congressman Kevin Cramer visited the incubator to connect with the tenant startups to understand the challenges they are facing Cramer reviewed the public policies in place to assist them and keep their businesses protected Clients were able to express their concerns and vision for changes directly to the Congressman The Organization hosted Molly Kocalski, Director of the Rocky Mountain Regional United States Patent and Trademark Office Ms Kocalski spent the day at the Incubator and embedded in the entrepreneurial community of Fargo After meeting with Park staff, University decision makers, the NDSU Research and Creative Activity office, and attending 1 Million Cups, Ms Kocalski spent the afternoon discussing of the patent process along with analogies that clarified the finer points of patent laws She expressed her open-door policy and ensured that those in need of assistance received immediate attention Several of the attendees were able to pursue their patents and/or trademarks with clear goals in mind after the session The USPTO intends to make the visit to the Fargo entrepreneurial community annually
