The application and documents are reviewed internally for accuracy and completeness. Complete applications that meet the qualification guidelines are reviewed monthly by a committee of completely independent people, usually composed of nurses, educators, lawyers, social workers and breast cancer survivors. The committee makes the final determination as to whether grants are made and for what amount. The Pink Fund treasurer then reviews the findings of the Committee and directs payments to be made directly to the recipients' creditors for up to ninety days, no money is sent directly to the successful applicants. The amount is based on an approved, overall monthly budget for program grants.
