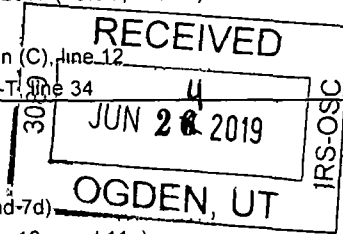

Emergent Health Partners administers a regional emergency medical transportation system encompassing four affiliated ambulance providers to improve patients' quality of medical care and quality of life. Emergent provides transportation services to residents in southeast and south central Michigan communities. By providing a rescue service for the relief of distressed persons who need emergency ambulance transportation, Emergent lessens the burden of government, who would otherwise have to provide such services.

The Emergent Health Partners (EHP) Center for EMS Education, formerly known as Huron Valley Ambulance (HVA) Center for EMS Education. Since 1981, the EHP Center for EMS has been educating students in the art and science of pre-hospital emergency care. The EHP Center for EMS Education is Nationally Accredited by the Commission on Accreditation of Allied Health Education. There are three campus locations. The main campus is located at 1200 State Circle Ann Arbor. The eastern campus is located at 1270 Goldsmith Road Plymouth. The western campus is located at 429 Ingham Street Jackson.
