 Spektral Quartet NFP contracts a classical string quartet (two violinists, one violist, one cellist) called the Spektral Quartet that serves the organization by promoting the education and expansion of music written for string quartet through performance and educational activities. Spektral Quartet NFP was formed in 2011 and since then has made in excess of 325 public appearances, commissioned more than 75 composers, and has worked with public and private University students around the Midwest and beyond, including the University of Chicago, where it serves as ensemble-in-residence. The large majority of the organization's activities occur within the Chicagoland Area, with some concert tours taking the quartet to New York, Washington D.C., Wisconsin, Michigan, Indiana, Ohio, North Carolina, Utah, California, and Washington state. The organization served in excess of 10,000 people during FY18.
