Abortion Assistance - CAF operates a funding helpline where calls are received by a voicemail system and returned by volunteers and staff who help distribute financial assistance and resource referrals to callers. We receive roughly 100 calls a week, and by the end of FY18 were able to double our monthly funding budget. We provide \$100-\$300 grants toward abortion procedures. Funds are transferred directly to clinics once a month. CAF provided assistance to approximately 900 callers in the year ended June 30, 2018. CAF also offered improved resource referral, case management for callers, and began a new caller follow up program.

Community Outreach - CAF expanded programming and volunteer support into new areas of the state. CAF collaborated with local and national abortion rights and reproductive health organizations to present film screenings, discussion panels, and interactive sessions on demystifying abortion care.

Reproductive Justice - CAF contracted Aorta Cooperative to deepen our internal understanding of reproductive justice and how it exists within CAF.
