SANDY RECOVERY AND RESILIENCY: AFTER HURRICANE SANDY IN 2012, THE BUDDING RESILIENCY PROGRAM RAMPED UP QUICKLY TO ADDRESS INCREASING NEEDS OF COMMUNITIES TO STRENGTHEN THEIR RESILIENCE TO CLIMATE CHANGE. IN FY18, THREE NEW ACTIONS WERE ADDED TO THE MUNICIPAL CERTIFICATION PROGRAM INCLUDING HEAT ISLAND ASSESSMENT, COASTAL VULNERABILITY ASSESSMENT, AND ENHANCED STORMWATER MANAGEMENT CONTROL ORDINANCE. TECHNICAL ASSISTANCE AND RESOURCES WERE PROVIDED TO ASSIST MUNICIPALITIES IN IMPLEMENTING THESE ACTIONS. SUSTAINABLE JERSEY ENTERED INTO A MASTER SERVICES AGREEMENT WITH THE COLLEGE OF NEW JERSEY TO RECEIVE ONGOING SERVICES AND FACILITATE CERTAIN SUSTAINABLE JERSEY GRANTS. AS PART OF THE ONGOING SERVICES RECEIVED, IT IS ESTIMATED THAT THE COLLEGE OF NEW JERSEY DONATED \$2,633 IN CONTRIBUTIONS AND EXPENSES RELATED TO THIS PROGRAM.
