The Organization shelters victims and children of domestic violence for a temporary period of time while they are looking for a new, safe place to live. The Organization also provides advocacy services for victims of domestic violence, sexual assault, bullying, and stalking. In FY2018, Safe Harbor assisted 1686 women, children and men that were victims of domestic violence. Safe Harbor also assisted 236 stalking victims, 80 sexual abuse victims, 42 adolescent sexual abuse victims, 10 child abuse victims, 70 domestic violence protection orders, and 35 stalking protection orders. The Organization sheltered 63 women and 72 children, providing 3,569 bed nights and 10,707 meals.

Kids Konnection served as a supervised visitation and exchange center for individuals referred by a court system, Department of Social Services, attorneys or others if there are difficulties exchanging children with another caretaker including when a court order restricts contact between parents or emotional safety is compromised.
