Community Service was provided to the Richardson TX community by providing continuing financial support to the City of Richardson (COR) to build a new all-inclusive park for its residents and to members of the larger community. In the previous fiscal year, the Foundation and its sponsor organization, the Richardson East Rotary Club (RERC) agreed to raise \$250,000 toward the construction and equipping of the park. During the current fiscal year, the Foundation raised \$165,821 directly from public sources and \$47,394 from the RERC for the project. In addition, the Foundation provided \$13,250 of scholarship payments to current and prior year recipients and approximately \$4,691 of funding for other COR public events including \$2,661 provided to fund the cost of a community picnic at a COR public park.

4b (Code:) (Expenses \$ 5,775 including grants of \$ 5,775) (Revenue \$ 0)

The Foundation partnered with the Rotary Foundation (RF), an affiliated 501(c)(3) organization located in Chicago, IL by providing \$5,775 in support of its philanthropic programs. The RF operates world wide and supports a number of humanitarian projects such as literacy, polio eradication, world peace and water and sanitation projects in developing countries.

The Foundation provided \$1,350 in scholarships to high school seniors to attend a youth leadership camp sponsored by an affiliated organization, Rotary Youth Leadership Award. The goal of the week long camp is to help high school students who have completed their junior year to become leaders among their peers by teaching team building, communication and problem solving skills - all while engaged in dynamic camp activities.
