RCASU has been classified as an organization that is a public charity. For tax purposes, income determined to be unrelated business income would be taxable. Except for the Mexican activity LLCs, all sole member LLCs under RCASU are treated as disregarded entities for income tax purposes, and accordingly, all income and expenses are reported through RCASU. The Mexican activity LLCs, Teo Holdings and Global I & II, have elected to be treated as for-profit entities and will report their income and expenses separately from RCASU for tax purposes. Tax positions taken related to RCASU's tax-exempt status and other miscellaneous tax positions have been reviewed. Management is of the opinion that material positions taken by RCASU would be upheld under examination. Accordingly, RCASU has not recorded an income tax liability for uncertain tax positions as of June 30, 2018 and June 30, 2017 and does not anticipate a significant change for the following twelve months. RCASU is subject to tax examination by the federal and Arizona state jurisdictions, which generally remain open for three and four years, respectively.
