As in previous years, our expenditures exceed our previous years' distributable amount because our charity raises funds for the school in Q1 of the fiscal year and spend it in Q2. Thus, as long as our income from the current year exceeds the previous year, we should always be well above threshold. Additionally, in 2017 we used up some of our surplus (approximately \$7500) which was distributed in the same direction as our main distributions. We reduced our surplus to approximately \$15,000 which we will try to maintain.

We do not actively raise funds after September of the tax year.

Regarding Section D. The supported organization (Nickajack Elementary School) is represented on our Board of Directors in a non-voting capacity. There are three staff members (Principal, Teacher Liaison and School Counsellor) who are invited to all meetings. As to our grant categories, large expenditures are discussed and agreed to with the Administration (iPads and Learning Commons), the universe of Teacher Grants are expressly authorized by school administration (though the Administration does not select specific grants) and the online Learning Tools are specifically selected in cooperation with the Administration and the Teachers. So, the target organization is completely integrated into the organization, but CANNOT vote on key issues like the mandate of the organization or specific actions.
