Discussions have been held with York Tecnical College and agreements reached for a \$25,000 endowed scholarship fund that will provide a \$1,000 scholarship each year for the foreseeable future. The agreement has not been signed as of June 30, 2018. \$9,375 has been donated which is earmarked for this fund.
