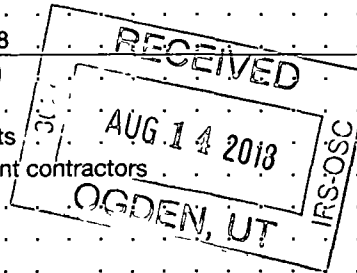

By resolution of the Board of Directors, effective July 1, 2018, all assets and liabilities, contracts, policies and procedures, financial accounting and books of account, etc. were transferred from the old association to the new non-profit corporation, with the same EIN and fiscal year. The Articles of Incorporation are attached. There is no material change in the text of the Articles of Incorporation and Bylaws for the new non-profit corporation, as compared to the prior non-profit association. The program of activities and charitable mission for "charitable and adult education services" remains exactly the same as prior to the conversion to the corporate form of organization, meeting the requirements of Section 501(c), as a public charity.
