Determination of whether conflicts exist are made at Board meetings, and restrictions on activities related to conflicts are imposed by the Board.

Comparability data was used to determine a range for the compensation, and the Board voted on the final amount, with consideration given to Clover's relatively small budget and the need to keep the compensation affordable. For other officers, the compensation is determined using comparability data, and all Board members vote on the amount except the officer for whom compensation is being determined. All voting is kept confidential. Compensation for the President was last adjusted in September 2016, and compensation for all other officers was last set in February 2015.
