National Homecare and Hospice Month, Is your home safe for older guests, Palliative and Hospice Care Q&A, Drug misuse for the elderly, Walking out of the hospital, Palliative care, We have jobs, Memory loss and advance care planning, New Medicare Cards, I do not need help, and Opioid addiction and serious illness Leadership served at Katie's Kitchen, St Mark's Lutheran Church in Butler, PA The kitchen provides a free meal every Thursday Individuals participate in serving the meal and cleanup afterwards Eight of our CCSS employees and members of management serve annually at Concordia Summer Festival in July and Concordia Oktoberfest in October Both events, which are held in Cabot, PA, are sponsored by Concordia Lutheran Health and Human Care and are open to the public as a way of providing entertainment, food and refreshments and a feeling of community One CCSS employee in particular devotes an extra 40 hours per year to coordinate the Kids Area for each festival which includes activities, crafts and face painting, all of which are provided free to the public Three employees of CCSS (including members of the management team) participate in "Servant Day" with St Luke Lutheran Church in Cabot, PA We gathered in September 2017 with a common mission "to improve the lives of others" The main event of the day was to frame two houses in the parking lot of the church which were then disassembled in sections and hauled to an underdeveloped area of the United States to be completed for a family in need Other smaller groups sewed dresses for at-risk girls for the agency was \$646 and includes salaries of the Human Resources Manager and the Director of Centralized Services and the cost of pens given away at the event The following local organizations have received direct financial support from Concordia Community Support Services through sponsorships of events Butler County Community College golf outing, Knoch Middle School yearbook, Butler Health System Foundation golf outing, Freeport Football Boosters advertisement Total cost to the agency for sponsorships for fiscal year ended 6/30/2018 equated \$488 Concordia Community Support Services made cash donations to various other 501(c)(3) organizations including Concordia Tele-CareGivers at a total of \$10,500 and Concordia Lutheran Ministries at a total of \$4,150,000 The donations are used to support other non-profits and further the mission of caring for God's people either through charitable care that supports patient's needs or to better serve both domestic and foreign
