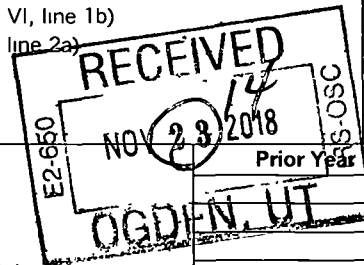

The Northwest Regional Adult Drug Treatment Court served 29 individuals in FY17. Four clients successfully completed the program. The NSVSAC collaborated with The Rotary Club of Winchester to meet some of the housing, transportation and food needs of the clients. Thanks to a grant from the United Way of the Northern Shenandoah Valley the NSVSAC was able to connect certified peer recovery specialists to 71 local residents who are living with addiction. With a powerful message of hope combined with the experience of success in their own recovery, peer recovery specialists serve as life coaches, extending the clinical reach of treatment and going directly into the lives of people who need them most. The peers assist the individuals with creating a Wellness Recovery Action Plan to identify goals and develop a plan to prevent substance use.
