- Criteria for evaluating the results of the project.

Grants are geographically limited to organizations within the United States, though strong preference will be given to organizations serving the needs of southwestern Pennsylvania. Support generally will not be granted to fraternal organizations; conferences or seminar attendance; specialized health campaigns; or national organizations. No support will be granted for private foundations as defined under Internal Revenue Code Section 509(a); loans or direct grants to individuals; or political campaigns, parties, or candidates.

The Organization awards scholarships as described in IRC Section 4945(g)(1) and/or fellowship grants described in IRC Section 117(a), awarded on an objective and nondiscriminatory basis, and used for study at an educational organization described in IRC Section 170(b)(1)(a)(ii).

The scholarships awarded are based on an intricate screening process based on the applications received. Basic requirements include that the student or an immediate family member must be a Washington Financial customer for at least 1 year, and the student must have at least 100 hours of community service during the 12-months preceding the month of application. Selection is based on a scoring system, which considers community service, class standing, and financial need. It is renewable up to a maximum of four years and the student must retain full-time status and a passing grade point average. Verification must be sent annually.
