This year applications were submitted by persons in five district schools, with requests ranging from \$240 to \$2,500. Applications were reviewed by a committee of foundation board members and awarded in May, 2018.

**Supported Fundraising.** The foundation also serves as a collection point for funds solicited by school groups that lack the means to easily raise funds on their own. Services provided include collecting funds (use of deposit account and PayPal), invoicing, and disbursement (check writing, use of debit card, etc.). School groups must be operating under the auspices of the school district.
