Dear Service Center Representative:

I am writing on behalf of the United Way of Leavenworth County, Inc. to request consideration pursuant to IRM 20.1.1.3.5 that you not assert a failure to file penalty with respect to the tax return filed with this letter.

The Organization exercised ordinary business care and prudence, but due to circumstances or events beyond its control it was unable to file timely. A timely extension was necessary due to the Executive Director leaving the organization with just 2 week's notice, however the short year extension, something completely new to the organization due to the recent change in fiscal year, was missed. The Organization could not have anticipated the events that caused the non-compliance which were:

Statement of Facts and Circumstances

- Form 1128 was filed to change the tax year end to 6/30 effective 6/30/2018.
- The Executive Director, Wendell E. Maddox, tendered his resignation letter on 1/29/2019, effective 2/15/2019; giving just a two-week notice.
- Over the next 10 months the organization experienced interim Leadership. Beginning May 1, Lisa Nevins became the new director. She did not finish the year.
- On Jan 20, 2020, the current Executive Director was appointed.

The above explanation constitutes reasonable cause under the law. The resignation of the executive director was a major change in the organizations management and leadership and affected its ability to accurately determine and meet its filing obligations, especially the requirement to file a short year return. The organization continued to attempt to meet the requirements, even though late. Unfortunately, the interim Executive Director was unfamiliar with the organization, and was not with the organization long enough to gain a sound understanding of the organization or the need to file a short year tax return necessitated by the recently filed Form 1128. For a period of time, the Organizations President stepped in until another Executive Director could be appointed. The organization seems to have landed on solid footing in that the current Executive Director had served on the Board of Directors over the years, understands the business operations and was certainly comfortable signing the resulting completed tax return after addressing any areas of concern with the preparing CPA. The organization did not fail to timely correct noncompliant behavior and they addressed this unfiled return expeditiously after having an interim Executive Director. As such, the organization is entitled to relief from the penalty.

Statements of Authority and Reasons for Abatement

Penalties for late filing of Form 990 are imposed under IRC section 6652(c)(1)(A)(i). However, paragraph 4 of subsection (c) under section 6652 provides that "No penalty shall be imposed under this subsection with respect to any failure if it is shown that such failure is due to reasonable cause."

While "reasonable cause" does not have a single clear definition in the code, IRS Regulation 301.6724-1(a) states that the penalty for a failure relating to a reporting requirement is waived if the failure is due to reasonable cause. Reasonable cause may be demonstrated if the filer establishes that there are significant mitigating factors with respect to the failure and that the filer acted in a responsible manner by exercising reasonable care, which is that standard of care a reasonably prudent person would use under the circumstances in the course of its business in determining its filing obligations. Further, it must be shown that the filer undertook significant steps to avoid or mitigate the failure once the failure was discovered.

As provided under Treasury Regulation Section 301.6724-1(a), we believe the preceding significant mitigating factors and responsible actions demonstrate reasonable cause for the late filing of the 2018 Form 990.

Absence of Willful Neglect

In addition to reasonable cause, the absence of "willful neglect" is mentioned in several places in the Code and in the Internal Revenue Manual as a factor to consider in determining if abatement of penalties is appropriate. Willful neglect may be understood as meaning "a conscious, intentional failure or reckless indifference." Since the organization took the deliberate action of bringing in an outside CPA with specific expertise in Form 990 and made continuous efforts to bring the final Form 990 to completion as soon as possible, willful neglect could not have been an element in the delinquency. We believe it is clear from the facts and circumstances stated herein that the Organization has not demonstrated willful neglect and that it takes seriously its responsibility for being in compliance with all filing requirements. The organization acted with ordinary business care and prudence and made a reasonable effort to be in compliance with 6033(a) (1) filing requirements.

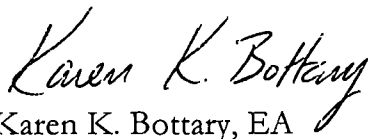
To prevent a future delay in tax filings, the organization has established a Board administrative procedure where it will discuss all critical action dates and filing requirements at each Board meeting so the entire board is aware of upcoming dates and filing requirements and any actions needed to facilitate timely tax filings.

Based on the organization's demonstration of the existence of significant mitigating factors with respect to the failures, and that it acted responsibly and without willful neglect with respect to its filing obligations, we respectfully request that the IRS recognize the existence of reasonable cause and abate/wave all assessed penalties and interest.

Thank you for considering our request.
