The organization provided services to over 41,000 individuals regarding sexual assault, domestic violence, teen dating violence, sexual harassment and/or stalking in the 17-18 fiscal year. 11,400 men and women called the 24-hour Rape and Battering Hotline for crisis intervention, support and referral information. Counseling, case management, emergency response to victims and accompaniment of victims at hospitals, courts and law enforcement were provided to 13,466 individual. Additionally, over 17,000 men, women and youth participated in community, school or professional education and training in violence prevention strategies.
