Promotes K-12 teacher professional development & instructional materials that support primarily in grades 6-12. In addition, a partnership with Morgan State University allows for a summer camp for middle and high schools students.

Academic scholarships for recipients continuing through college in pursuit of their degree.

The Superintendent's Breakfast was convened for a second time and now focuses on STEM careers and disciplines. Students who have passed Advance Placement courses ask STEM professionals and academicians questions about career and college, while having breakfast. Following breakfast a STEM CEO is interviewed on stage about the CEO's personal pathway to STEM leadership; about what the CEO's organization does; and about trends in the STEM sector represented by the CEO.

We piloted the Dine with Dignity Program in six MCPS schools -- two elementary schools, two middle schools, and two high schools. Traditional school lunches are exchanged for alternative meals and given to students who do not qualify for free lunch and have lunch account balances negative \$10 or more. The alternative meal identifies them to peers as not having money to buy lunch. The Dine with Dignity Fund is available to pay off lunch balances that remain after families have contributed toward the amount due. The program will be implemented districtwide in FY2019.
