Pt I Line 2: Maryland Energy Assistance Fund staff identifies low-income families and individuals who are on the verge of having their heat and electricity cut-off. The staff verifies their information and assesses their qualifications before inputting each client into the State's software to help determine and track their qualified amounts. The Housing Program utilizes funds to provide case management services and consultation services to prevent evictions, foreclosures and homelessness. Each client meets with a staff member for an interview, and the staff then determines on a case-by-case basis what assistance they can provide. Early Head Start utilizes the funds for both parent involvement and program recruitment. Each family meets with the staff first to see if they are eligible for the program and, once enrolled, to maintain ongoing involvement in their child's development.
