Without access to healthy food, a nutritious diet and good health are out of reach. An essential component of First Nations' nonprofit capacity-building strategy is our Leadership, Entrepreneurial, and Apprenticeship Development (LEAD) Institute Conference that trains emerging and existing Native nonprofit leaders, including staff members from many of our grantee organizations. For 22 years, First Nations has held an annual LEAD Institute Conference for Native American nonprofit professionals, tribal leaders and anyone interested in Native nonprofits, business and philanthropy.

The goal is to provide programs that meet youth where they are, support them in accomplishing their goals and dreams, and prepare them for an empowered adulthood guided by their cultures, families and traditions.
