ENTREPRENEUR PROGRAM - CIT concentrates on the early commercialization and seed funding stages of innovation, helping tech entrepreneurs launch and grow their companies and create high paying jobs. CIT Growth Acceleration Program (GAP) Funds place equity investments in Virginia-based technology, life science, and clean tech companies. Since the program's inception, \$26M in GAP investments have attracted in \$800M in private capital. The newly formed Virginia Founders Fund (VFF) serves underserved populations, and created 4 new startups in FY2018. CIT's Federal Funding Assistance Program (FFAP) identifies and accelerates opportunities for Virginia's small technology businesses to obtain SBIR, STTR and ATP awards and other government contracts. Program service revenue consists primarily of proceeds on liquidated GAP investments.

COMMONWEALTH RESEARCH COMMERCIALIZATION FUND (CRCF) - Through its granting program, the CRCF accelerates innovation and economic growth in Virginia by addressing state, national, and international problems. Having awarded \$25M in Commonwealth funding and \$66M in match funding, awardees have received ~\$500M in follow-on funding since FY2015.

CIT grows and diversifies Virginia's economy through programs focusing on broadband availability, smart communities and unmanned systems. Recognizing the role that broadband connectivity plays in the innovation economy, CIT delivers expert broadband guidance and strategies to local governments to facilitate access to affordable broadband services, as well as providing support to the Governor's Chief Broadband Advisor and Broadband Advisory Council. CIT co-founded the Smart City Works accelerator, leads the Smart Communities Working Group, and funds smart cities and IOT startups. CIT leads the Commonwealth's Unmanned Systems Center of Excellence to attract startups and companies to Virginia.
