THE WESTMINSTER-CANTERBURY OF THE BLUE RIDGE FOUNDATION WAS ESTABLISHED IN 1998 AS A 501(C)(3), NONPROFIT ORGANIZATION TO SUPPORT THE MISSION OF WESTMINSTER-CANTERBURY OF THE BLUE RIDGE ("WCBR"). THE FOUNDATION'S MISSION IS TO GATHER PRIVATE SUPPORT FOR WCBR'S CHARITABLE ACTIVITIES, INCLUDING THE FELLOWSHIP FUND, WHICH PROVIDES CONFIDENTIAL FINANCIAL ASSISTANCE TO RESIDENTS IN NEED PRIOR TO THE ESTABLISHMENT OF THE FOUNDATION, WESTMINSTER-CANTERBURY OF THE BLUE RIDGE CONDUCTED ITS OWN FUNDRAISING ACTIVITIES. IN 2008, WESTMINSTER-CANTERBURY OF THE BLUE RIDGE AND WESTMINSTER-CANTERBURY OF THE BLUE RIDGE FOUNDATION FORMED AN OBLIGATED GROUP, THEREBY PERMITTING THE TRANSFER OF CHARITABLE FUNDS HELD BY THE CORPORATION TO THE FOUNDATION. ALSO IN 2008, THE FOUNDATION ESTABLISHED A FUND TO PROVIDE SCHOLARSHIPS TO EMPLOYEES MEETING CERTAIN ELIGIBILITY REQUIREMENTS. IN 2011 THE FOUNDATION ESTABLISHED A FUND TO PROVIDE EMERGENCY GRANTS TO EMPLOYEES WHO HAD AN ELIGIBLE UNEXPECTED EMERGENCY.
